**WARNING:** When using the Night Vision Goggles, always follow these safety instructions:

If you experience any discomfort or disorientation, remove goggles immediately. Always use good judgment and common sense.

**NEVER** wear while operating vehicles or riding bicycles, skateboards, scooters, or skates.  
**NEVER** explore surroundings that might be considered dangerous even during daytime.  
**NEVER** use goggles as a life saving device.  
**NEVER** use goggles to look directly into sun.  
Not recommended to use goggles outdoor.  
**NEVER** stare directly at the Long Range IR LED when it is on.

This device is **NOT** weather proof and may be damaged when exposed to rainy condition. The operation temperature is -10 degree to 40 degree Celsius (14 degree to 104 degree Fahrenheit). The battery life will be affected by cold weather.

**ALWAYS** inspect your surroundings in daylight or with bright lights for hazards before using goggles.

**ALWAYS** fully charge the battery with USB cable before using goggles.

**ALWAYS** carry a flashlight and portable USB charger and USB cable in case of batteries run down.

**ALWAYS** use caution with goggles since peripheral vision and depth perception are restricted. Scan continuously from side to side for hazards.

Objects or persons viewed through goggles may be larger or closer than they appear. Goggles (with reduced illumination and contrast) do not provide the same level of vision sharpness and image clarity compared to daylight conditions.

When removing goggles, allow time for your eyes to adjust and adapt to the darkness before moving around again. Take frequent breaks to prevent eye strain and tiredness. Turn the Eye Width Adjustment knobs at the left and right ends to adjust the alignment of left and right screen visions.

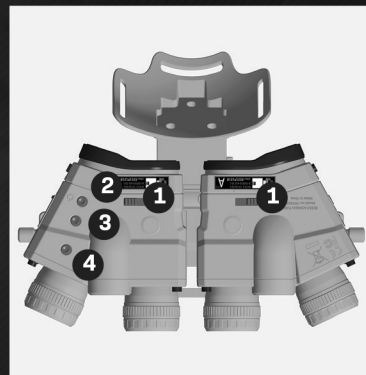
Please fully charge the goggles before use (please refer to below illustration).

**Please read the following instructions before wearing.**

Adjust the LEFT AND RIGHT head straps to fit your head size, adjust the TOP head strap to set goggles at a horizontal position without tilting up or down.

The external battery pack at the back is for decoration purpose without any power supply function. It may be used as a small container if desired.

The cable connected from battery pack to the goggles is for decoration purpose without function.



## 1. Focus Adjustment

Adjust the focusing of the image

## 2. Power On/Off Switch

## 3. Black & White Screen Mode On/Off

Operate only at night vision mode, press once to switch to black and white screen, press again to return to default blue screen at night vision mode

## 4. Long Range IR LED Switch

In this mode, the goggle operates at full power and emits a barely visible ring of red light. See up to 20 meters in absolute darkness.



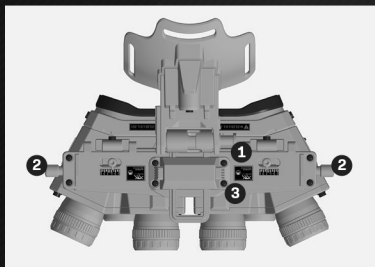

## 1. Hinge Release Button

Flip up the goggles by pressing the button to release the lock. Press the button again and flip the goggles down to return to the original position.

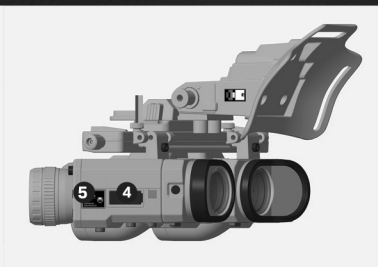
## 2. Eye Width Adjustment

Turn the left and right knobs to adjust the transverse displacement of left and right goggles respectively

## 3. Eye Distance Adjustment

Press BOTH buttons on sides to release and slide to adjust the distance between goggles lens and eyes

The Night Vision Goggles are adjustable to fit most users. Adjust the middle strap simply by pulling the band to tighten or loosen the fit. Adjust the straps



on the left and right sides to tighten or loosen. Some users may see two images when first looking through the goggles. Turn the Eye Width Adjustment knobs at the left and right ends to adjust the alignment of left and right screen visions.

## 4. USB Charging Port

Open the small soft lid on the left side of goggles to reveal the USB charging port. The LED will light up in RED during charging and turns to GREEN when the battery is fully charged.

## 5. USB Soft Cover

**CAUTION : TURN OFF GOGGLES POWER DURING CHARGING**

## Battery Power Display

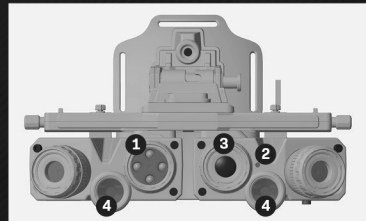
Battery icon turns on in the following conditions and turns off automatically after display for approximately 10 seconds:

- Power up
- The MODE button was pressed
- Changing between Daylight and Night Vision modes

Battery icon remains on and will not turn off in the following conditions:

- When Battery Level is down to one or empty bar
- When charging while the Goggle is in power ON

Battery icon flashing when Battery Level is down to one or empty bar



## 1. Short Range IR LED

When the goggles switch to Night mode (in low illumination environment), the Short Range IR LED will be switched on automatically

## 2. Light Sensor

**CAUTION :** Do not cover the light sensor during use, otherwise, the goggles will not detect the illumination of environment and cannot switch between day and night mode automatically.

## 3. Night Vision View Camera

Do not cover the view camera during use

## 4. Long Range IR LED

Only switch on the long range IR LED if needed to increase the night vision distance up to 20 meters. **CAUTION: TURNING ON THE LONG RANGE IR LED WILL INCREASE THE BATTERY POWER CONSUMPTION**

## COLLECTOR'S STAND

The Night Vision Goggle Collector's Stand can be used to display the Goggles when they are not being used. Pull the straps of the Goggles around the round portion of the stand (#5) and rest the Goggles on the flat shelf (#3). The stand requires no tools to assemble. You can snap and slide together the components to complete the setup of the stand (see the visual guide included below).

### WARNING:
